

Continuing Education Flight Courses

North Central Institute (NCI) maintains partnerships with reputable CFR Part 141 flight training schools in the country. SkyWarrior Flight Training (located in Pensacola, Florida), CAE Aviation Academy Phoenix (located in Phoenix, Arizona), and AeroGuard Flight Training Center (located in Goodyear, Arizona) provide flight training courses to those interested in continuing their aviation education. The objective is to prepare students to obtain a private pilot certification (PPC), with an instrument rating (IR) and/or multi-engine rating (ME).

Through these partnerships, students may elect to attend SkyWarrior Flight Training, CAE Aviation Academy Phoenix, or AeroGuard Flight Training Center. The training partner will provide the following training courses at one of its approved CFR Part 141 training facilities. Students may elect to participate in one or multiple training courses.

AVI 100 – Private Pilot Certification (PPC) – 6 Credit Hours

Students will complete the required ground, dual, and solo flight instruction to meet the FAA requirements for the Private Pilot Certificate. In addition, this course covers the requirements for all ground and pre/post flight training to enable the student to successfully complete the FAA Private Pilot Written Exam. Students who enter the course must be able to hold an FAA class 3 medical certificate required to complete the Private Pilot Certificate check ride.

AVI 110 – Instrument Rating Certification (IR) – 6 Credit Hours

Students will complete the required ground, dual, and solo flight instruction to meet the FAA requirements for the Instrument Rating. In addition, this course covers the requirements for all ground and pre/post flight training to enable the student to successfully complete the FAA Instrument Pilot Written Exam. Students who enter the course must be able to hold an FAA class 3 medical certificate required to complete the Instrument Rating check ride.

AVI 120 – Multi-Engine Rating (ME) – 6 Credit Hours

Students will complete the required ground, dual, and solo flight instruction to meet the FAA requirements for the Multi-Engine Rating. This rating may be done as either a Commercial add-on or a Private Pilot add-on. Students who enter the course must be able to hold an FAA class 3 medical certificate required to complete the Multi-Engine Rating check ride.

Schedule: Ground Classes meet Monday – Friday, 8:00 a.m. – 5:00 p.m.

- Morning class is held from 8:00 a.m. – 12:00 p.m.
- Afternoon class is held from 1:00 p.m. – 5:00 p.m.

Flight classes meet Monday – Sunday, Flight schedules vary to include night flying sessions.
